- 3. Contact details (postal address with PIN, Mobile Number and E-mail address)
- 4. Bank Account details (Bank and branch name, bank account number, MICR, IFS Code)
- 5. Specimen Signature through Form ISR-2

Therefore, you are requested to comply with the following procedure to update PAN, KYC & Nomination Details etc.:-

- 1. First Link your PAN with Aadhar. Update the valid PAN with RTA in Form ISR-1.
- 2. Register/update your PAN, KYC details (Contact details, Bank Account details, Signature) in **Form ISR-1** and Nomination details in **Form SH-13** with our RTA.
- 3. To register/update the signature in the Company/RTA records, submit **Form ISR-2** duly Verified by your Bank.

- 4. In case you do not wish to nominate any person with whom shall vest, all the rights in respect of such shares in the event of your death, you shall submit 'Declaration to Optout' in Form ISR-3 with our RTA.
